of the records of the County of Arapahoe, State of Colorado, shall be amended and changed to read as follows, to-wit:

"The Principal Dwelling shall have a minimum fully enclosed floor area devoted to living purposes exclusive of porches, terraces, garage, guest house and servant quarters of 1900 square feet."

IT IS FURTHER UNDERSTOOD AND ACREED that this Amendment shall not in any way change any of the other restrictions, covenants and conditions in said Use and Building Restrictions and that this Amendment shall be subject to the same restrictions, covenants and conditions of the Use and Building Restrictions set out in Book 1014 at Page 339, noted above.


