NOW, THEREFORE, pursuant to the provisions of Article 6 of the By-laws, the Association hereby amends the By-laws as follows:

BY DELETING SECTION 3 OF ARTICLE 2 OF THE BY-LAWS IN ITS ENTIRETY AND, SUBSTITUTING THEREFOR, INSERT THE FOLLOWING:

"Section 3. Meetings. Annual meetings of the Association shall be held in the final quarter of the calendar year. At such meeting, there shall be an election for any open seats on the Executive Board, a vote on the Budget for next fiscal year and any other business which may come before the membership. For elections when there is more than one candidate for an open seat on the Executive Board, an election shall be held by written ballot."

IN ALL OTHER RESPECTS, THE BY-LAWS OF 903 CONDOMINIUM OWNER'S ASSOCIATION, INC. SHALL REMAIN IN FULL FORCE AND EFFECT AND ARE RATIFIED AND REAFFIRMED.
